



COUNT 3

On or about April 19, 2023, in the County of Los Angeles, the crime of PETTY THEFT, in violation of PENAL CODE SECTION 484(a), a Misdemeanor, was committed by ALAN CARRILLO, who did unlawfully steal, take, carry, lead, and drive away the personal property of M M., specifically, knife, which had a value not exceeding nine hundred fifty dollars (\$950).

COUNT 4

On or about June 15, 2023, in the County of Los Angeles, the crime of ALTERING, PLANTING, OR CONCEALING EVIDENCE, AS A PEACE OFFICER, in violation of PENAL CODE SECTION 141(b), a Felony, was committed by ALAN CARRILLO, who was a peace officer, who did knowingly, willfully, intentionally, and wrongfully alter, modify, plant, place, manufacture, conceal, and move any physical matter, digital image and video recording, with the specific intent that it would be concealed and destroyed, and fraudulently represented as the original evidence in a trial, proceeding, and inquiry.

NOTICE: Upon a felony conviction for the above offense, prison custody time is to be served in state prison pursuant to Penal Code section 1170.

COUNT 5

On or about June 15, 2023, in the County of Los Angeles, the crime of PETTY THEFT, in violation of PENAL CODE SECTION 484(a), a Misdemeanor, was committed by ALAN CARRILLO, who did unlawfully steal, take, carry, lead, and drive away the personal property of S G., specifically, brass knuckles, which had a value not exceeding nine hundred fifty dollars (\$950).

**NOTICE: Conviction of this offense will require the defendant to provide DNA samples and print impressions pursuant to Penal Code sections 296 and 296.1. Willful refusal to provide the samples and impressions is a crime.**

**NOTICE: The People of the State of California intend to present evidence and seek jury findings regarding all applicable circumstances in aggravation, pursuant to Penal Code section 1170(b) and *Cunningham v. California* (2007) 549 U.S. 270.**

**NOTICE: A Suspected Child Abuse Report (SCAR) may have been generated within the meaning of Penal Code §§ 11166 and 11168 involving the charges alleged in this complaint. Dissemination of a SCAR is limited by Penal Code §§ 11167 and 11167.5 and a court order is required for full disclosure of the contents of a SCAR.**

**NOTICE: Any allegation making a defendant ineligible to serve a state prison sentence in the county jail shall not be subject to dismissal pursuant to Penal Code § 1385.**

**NOTICE: Conviction of this offense prohibits you from owning, purchasing, receiving, possessing, or having under your custody and control any firearms, and effective January 1, 2018, will require you to complete a Prohibited Persons Relinquishment Form (“PPR”) pursuant to Penal Code § 29810.**

Further, attached hereto and incorporated herein are official reports and documents of a law enforcement agency which the undersigned believes establish probable cause for the arrest of defendant(s) ALAN CARRILLO for the above-listed crimes. Wherefore, a warrant of arrest is requested for ALAN CARRILLO.
